3. There are two instances where multiple obligated products may be packaged by the original equipment manufacturer (OEM) in a single physical package carrying a single SKU (stock-keeping unit) and be subject to one EHF for the entire package of products:
- Where the product definition above specifically includes multiple obligated products, or
 - Where a product is comprised of different functional components that are sometimes sold separately, but in this case are integrated into a single operating unit. In this instance the integrated product carries the single highest EHF. Examples include:

Phase I

- All-in-One computer system (desktop CPU with integrated display device)
- Display device with integrated video player (DVD, VCR, Blu-ray, etc.)
- Printer / Scanner / Fax (all-in-ones)

Phase II

- Multiple drive players integrated into a single device – e.g. DVD & VCR player
- Fax machine with a corded telephone handset
- Telephone with built-in answering machine
- Security display monitor with built-in digital video recorder (DVR)

Phase III

- Floor Standing Multi-Function Devices
- Countertop Microwave Ovens

Phase IV

- Time Measurement Devices
- Weight Measurement Devices
- Air Treatment Appliances
- Garment Care Appliances
- Personal Care Appliances
- Kitchen Countertop Heating and Cooking Appliance
- Kitchen Countertop Motorized Appliances
- Kitchen Countertop Appliances For Making Hot Beverages
- Small Floor Cleaning Device
- Full Size Floor Cleaning Devices
